## LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

# The Bassetlaw District Council (Reorganisation of Community Governance) Order 2014

Made 28<sup>th</sup> November 2014 Coming into force in accordance with article 1(2)

Bassetlaw District Council ("the Council"), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 ("the 2007 Act"), has undertaken a community governance review and made recommendations dated 26<sup>th</sup> June 2014.

The Council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient.

The Council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section.

The Council makes the following Order in exercise of the powers conferred by sections 86 and 240(10) of the 2007 Act.

### 1. Citation and commencement

- (1) This Order may be cited as the Bassetlaw District Council (Reorganisation of Community Governance) Order 2014.
- (2) This Order comes into force on the day after it is made.

### 2. Interpretation

In this Order -

"district" means the district of Bassetlaw;

"existing" means existing on the date this Order is made;

"map" means the relevant map marked "Map referred to in the Bassetlaw District Council (Reorganisation of Community Governance) Order 2014" and numbered 1–6 (as the context allows) and deposited in accordance with section 96(4) of the 2007 Act;

"registration officer" means an officer appointed for the purpose of, and in accordance with, section 8 of the Representation of the People Act 1983.

#### 3. Effect of Order

This Order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provision of this Order.

## 4. Amalgamation of existing parishes of Cuckney and Norton and constitution of new parish of Norton and Cuckney Parish

- (1) The existing parishes of Cuckney and Norton shall be amalgamated to constitute a new parish comprising the area outlined in red on Map 1.
- (2) The new parish shall be known as Norton and Cuckney Parish.
- (3) In consequence of paragraph (1), the existing parishes of Cuckney and Norton shall cease to exist.
- (4) The number of councillors to be elected for the Parish of Norton and Cuckney will be 7.
- (5) The election of all parish councillors for the Parish of Norton and Cuckney shall be held on the ordinary day of election of councillors in 2015.
- (6) The annual meeting of the new parish council in 2015 shall be convened by the Chief Executive of Bassetlaw District Council. The meeting shall take place no later than 14 days after the day on which the councillors elected to the new parish council take office.

### 5. Dissolving the North Wheatley and South Wheatley group of parishes under the name of North and South Wheatley Parish Council

- (1) The North and South Wheatley group of parishes shall be dissolved.
- (2) The North and South Wheatley Parish name for the group of parishes shall be wound up and dissolved.

## 6. Amalgamation of existing parishes of North Wheatley and South Wheatley and constitution of new parish of North and South Wheatley Parish

- (1) The existing parishes of North Wheatley and South Wheatley shall be amalgamated to constitute a new parish comprising the area outlined in red on Map 2.
- (2) The new parish shall be known as North and South Wheatley Parish.
- (3) In consequence of paragraph (1), the existing parishes of North Wheatley and South Wheatley shall cease to exist.
- (4) The number of councillors to be elected for the Parish of North and South Wheatley will be 10.
- (5) The election of all parish councillors for the Parish of North and South Wheatley shall be held on the ordinary day of election of councillors in 2015.
- (6) The annual meeting of the new parish council in 2015 shall be convened by the Chief Executive of Bassetlaw District Council. The meeting shall take place no later than 14 days after the day on which the councillors elected to the new parish council take office.

7. The Number of parish councillors for the parish of Eaton

The number of councillors to be elected for the parish of Eaton shall be reduced from 3 to 2. This will be effective from the ordinary day of election in 2015.

8. The Number of parish councillors for the parish of Gamston

The number of councillors to be elected for the parish of Gamston shall be reduced from 7 to 5. This will be effective from the ordinary day of election in 2015.

9. The Number of parish councillors for the parish of West Drayton

The number of councillors to be elected for the parish of West Drayton shall be reduced from 6 to 4. This will be effective from the ordinary day of election in 2015.

10. Removal of Wards for Harworth and Bircotes Town Council

- (1) The existing wards of East and West of the parish of Harworth and Bircotes shall be abolished.
- (2) The number of councillors to be elected for the parish of Harworth and Bircotes shall be 15.

11. Electoral register

The registration officer for the district shall make such rearrangement of, or adaptation of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

#### 12. Order date

1st April 2015 is the order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.



Bassetlaw District Council (Reorganisation of Community Governance) Order 2014 Norton and Cuckney Parish Council




