DIRECTION MADE UNDER ARTICLE 4(1) TO WHICH PARAGRAPHS 1(9), 1(10), 2(6) AND 2(7) OF SCHEDULE 3 APPLIES

BASSETLAW DISTRICT COUNCIL (WOODEND FARMHOUSE, COACH ROAD, SHIREOAKS) ARTICLE 4(1) DIRECTION – 12TH SEPTEMBER 2019

WHEREAS the Council of the District of Bassetlaw (hereafter called the "the Council") being the appropriate Local Planning Authority within the meaning of Article 4 and Schedule 3 of the Town and Country Planning (General Permitted Development) (England) Order 2015 as amended (hereinafter called "the order"), are satisfied that it is expedient that development of the descriptions set out in the Schedule below should not be carried out on the land and building coloured red on the attached plan unless permission is granted on an application made under Part III of the Town and Country Planning Act 1990.

AND WHEREAS the Council considers that development of the said descriptions would constitute a threat to the amenities of the area.

NOW THEREFORE the said Council in pursuance of the power conferred on them by Article 4(1) of the Order hereby direct that the permission granted by Article 3 of the said Order shall not apply to development on the said land of the descriptions set out in the Schedule below.

THIS DIRECTION was made on 25^{th} April 2019 under Paragraph 2(1) (a) of Schedule 3 (Article 4(1)) of the said Order. In accordance with Paragraphs 2(6), 2(7), 1(9) and 1(10) of Schedule 3 of the Order, the Council confirmed the Article 4(1) Direction on 12^{th} September 2019.

SCHEDULE

Development to which the Direction shall apply (specified by reference to the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended):

Schedule 2, Part 1 – Development in the Curtilage of a Dwellinghouse

<u>Class A – External rendering or the removal of a chimney stack</u> The external rendering of the building, or the removal of an existing chimney stack.

<u>Class G – The reduction or replacement of a chimney stack</u> The reduction in height, or the replacement, of an existing chimney stack.

Schedule 2, Part 2 – Minor Works

<u>Class C – Exterior Painting</u> The painting of any part of the external stonework.

Schedule 2, Part 11 – Heritage and Demolition

Class B – Demolition of Buildings

Any building operation consisting of the demolition of a building which is coloured red on the attached map.
